All these events are revisited. The author has expressed original opinions and explanations of the record that will disagree in some instances from interpretations of these events here by others. The author hopes that this informal telling of a story, will contribute to an appreciation that living today in an enlightened time that aspires to provide equal justice for all under common law is far superior to tribal life in a far distant Dark Ages when might-made-right and getting-even was the accepted goal of justice by tribal barbarians.
