TYPES OF DATA APPLE CAN PROVIDE

WHEN LAW ENFORCEMENT SUBMITS A VALID LEGAL REQUEST, APPLE CAN PROVIDE CERTAIN TYPES OF DATA STORED IN ICLOUD OR OTHER APPLE SERVICES, SUCH AS:

- ICLOUD BACKUPS (IF ENABLED BY THE USER)
- PHOTOS AND VIDEOS STORED IN ICLOUD PHOTO LIBRARY
- CONTACTS, CALENDARS, REMINDERS
- IMESSAGES AND SMS MESSAGES STORED IN ICLOUD (DEPENDENT ON SETTINGS)
- APPLE ID ACCOUNT INFORMATION
- DEVICE INFORMATION LIKE SERIAL NUMBERS AND PURCHASE HISTORY

HOWEVER, END-TO-END ENCRYPTED DATA, INCLUDING THE CONTENTS OF THE IPHONE'S LOCAL STORAGE AND APPLE PAY INFORMATION, CANNOT BE ACCESSED BY APPLE FOR LAW ENFORCEMENT.

LEGAL FRAMEWORKS AND COMPLIANCE STANDARDS

APPLE'S COMPLIANCE WITH LAW ENFORCEMENT REQUESTS IS GOVERNED BY APPLICABLE LAWS SUCH AS THE ELECTRONIC COMMUNICATIONS PRIVACY ACT (ECPA) IN THE UNITED STATES AND INTERNATIONAL TREATIES ELSEWHERE. THE COMPANY
