Once he was freed in 1952, he began a steady ascent to become the face of the Nation, a platform from which he

gained notoriety for advocating the Nation's teachings about black supremacy. Whereas Dr. King was pushing for fuller integration and desegregation, X and the Nation of Islam advocated total separation. Other Civil Rights organizations deemed X and the Nation to be too extremist, and in response X labeled them "stooges". Today, one of the best known aspects of Malcolm X's life was his assassination in 1965 by members of the Nation of Islam following his split from the group over differences with leader Elijah Muhammad. In addition to making a pilgrimage to Mecca, X continued to be politically active, founding a number of groups and speaking to many more in an attempt to heighten political awareness. Over the last two years of his life, he faced several threats from the Nation of Islam, which culminated with his assassination on February 21, 1965, as he was addressing the Organization of Afro-American Unity in Manhattan's Audubon Ballroom. Coverage of each man was compared with the other for evidence of framing. The study found four recurring themes surrounding the coverage of these two men: the diminishment of Malcolm X as a leader, a mistrust and skepticism of Malcolm X and the Black Muslims, a deep fear of racial violence, and the stigmatization of Malcolm X. Through this framing, Malcolm X was labeled as a deviant while Martin Luther King, Jr., was embraced as a righteous leader. These characterizations reinforced hegemonic power structures while also supporting ideological notions of accepted ideologies in the United States
