#### DEVELOP A FITNESS ROUTINE

START WITH A BALANCED FITNESS PROGRAM INCORPORATING CARDIOVASCULAR EXERCISES, STRENGTH TRAINING, AND FLEXIBILITY WORKOUTS. RUNNING, SWIMMING, OR CYCLING CAN IMPROVE STAMINA, WHILE WEIGHT TRAINING BUILDS THE MUSCLE STRENGTH NECESSARY FOR PHYSICAL CONFRONTATIONS OR RESCUE OPERATIONS.

#### PRACTICE SPECIFIC TEST COMPONENTS

IF POSSIBLE, FIND OUT THE EXACT PHYSICAL TESTS SEPTA REQUIRES AND PRACTICE THOSE MOVEMENTS. FOR EXAMPLE, TIMED SPRINTS OR PUSH-UP COUNTS. THIS TARGETED PREPARATION REDUCES ANXIETY AND IMPROVES PERFORMANCE ON TEST DAY.

## ADDITIONAL TIPS FOR SUCCESS

BEYOND STUDYING AND PHYSICAL CONDITIONING, SEVERAL OTHER FACTORS CAN INFLUENCE YOUR SUCCESS ON THE SEPTA POLICE EXAM.

- OBSTACLE COURSES OR SPRINT DRILLS TO ASSESS AGILITY AND ENDURANCE

CANDIDATES ARE ADVISED TO BEGIN A TAILORED FITNESS REGIME WELL BEFORE THE EXAM DATE TO MEET OR EXCEED THE REQUIRED STANDARDS. FAILURE TO PASS THE PHYSICAL FITNESS TEST CAN RESULT IN DISQUALIFICATION REGARDLESS OF WRITTEN EXAM PERFORMANCE.
