HOHOFF SAW THE POTENTIAL IN LEE'S PORTRAYAL OF INNOCENCE CONFRONTING HARSH SOCIETAL REALITIES AND ENCOURAGED HER TO REFOCUS THE NARRATIVE ON SCOUT'S YOUTH, WHICH EVENTUALLY BECAME TO KILL A MOCKINGBIRD.

THE PUBLICATION PROCESS AND INITIAL RECEPTION

THE PUBLICATION OF TO KILL A MOCKINGBIRD TOOK PLACE IN 1960, A TIME WHEN AMERICA WAS GRAPPLING WITH CIVIL RIGHTS ISSUES. LIPPINCOTT PUBLISHED THE NOVEL IN JULY 1960, AND IT WAS MET WITH CRITICAL ACCLAIM ALMOST IMMEDIATELY.
