KEY FIGURES INCLUDED GEORGE WASHINGTON, WHO PRESIDED OVER THE CONVENTION; JAMES MADISON, OFTEN CALLED THE "FATHER OF THE CONSTITUTION"; BENJAMIN FRANKLIN; AND ALEXANDER HAMILTON. THEIR DEBATES AND COMPROMISES FORMED THE FOUNDATION OF THE U.S. CONSTITUTION.
