PRACTICE TIME MANAGEMENT

SINCE THE EXAM IS TIMED, DEVELOP STRATEGIES TO PACE YOURSELF. IF YOU’RE STUCK ON A PARTICULARLY DIFFICULT QUESTION, IT MAY BE BETTER TO MOVE ON AND RETURN LATER IF TIME PERMITS.

ONE NOTABLE FEATURE OF THESE SAMPLE QUESTIONS IS THEIR EMPHASIS ON ACCURACY AND ATTENTION TO DETAIL. MINOR NUANCES IN THE CLINICAL DOCUMENTATION—SUCH AS THE PRESENCE OF COMORBIDITIES, LATERALITY, AND EPISODE OF CARE—CAN DRASTICALLY INFLUENCE THE CORRECT CODING CHOICE. THIS REFLECTS THE REAL-WORLD DEMANDS FACED BY PROFESSIONAL CODERS, WHERE PRECISION DIRECTLY IMPACTS REIMBURSEMENT AND COMPLIANCE.

PROS AND CONS OF USING SAMPLE QUESTIONS FOR EXAM PREPARATION
