THESE PHILOSOPHICAL FOUNDATIONS ARE ECHOED IN MODERN STATEMENTS LIKE LORD BINGHAM’S ASSERTION THAT “THE RULE OF LAW MEANS THAT ALL PERSONS AND AUTHORITIES WITHIN THE STATE, WHETHER PUBLIC OR PRIVATE, SHOULD BE BOUND BY AND ENTITLED TO THE BENEFIT OF LAWS PUBLICLY MADE, TAKING EFFECT (GENERALLY) IN THE FUTURE AND PUBLICLY ADMINISTERED IN THE COURTS.”

ANALYZING KEY THEMES IN RULE OF LAW QUOTES

LEGAL CERTAINTY AND PREDICTABILITY

ANOTHER IMPORTANT ASPECT IS THE PREDICTABILITY OF LAWS. CITIZENS AND INSTITUTIONS MUST BE ABLE TO ANTICIPATE LEGAL CONSEQUENCES TO PLAN THEIR ACTIONS ACCORDINGLY. AS LEGAL SCHOLAR A.V. ACCOUNTABILITY AND TRANSPARENCY

ACCOUNTABILITY OF GOVERNMENT OFFICIALS AND TRANSPARENCY IN THE APPLICATION OF LAWS ARE FREQUENTLY EMPHASIZED. THE RULE OF LAW QUOTES OFTEN SERVE AS A CRITIQUE OF CORRUPTION AND ARBITRARY GOVERNANCE.
