BALANCING THESE PROS AND CONS IS ESSENTIAL WHEN SELECTING CASE STUDIES AS A RESEARCH METHOD IN EDUCATIONAL INQUIRY.

Furthermore, collaborative case study research involving multiple institutions can provide comparative perspectives, enhancing the robustness of findings. Such initiatives encourage methodological rigor and increase the potential for scalable educational improvements.
