RECOGNIZING ROAD SIGNS INSTANTLY IS CRUCIAL DURING THE TEST AND REAL-LIFE DRIVING. TO IMPROVE, PRACTICE IDENTIFYING SIGNS IN REAL-WORLD SETTINGS OR THROUGH INTERACTIVE TOOLS THAT TEST YOUR RECOGNITION SPEED.
