UNDERSTANDING THE ROLE OF THE NEW RELIEF SOCIETY PRESIDENCY

THE RELIEF SOCIETY, ONE OF THE OLDEST AND LARGEST WOMEN'S ORGANIZATIONS IN THE WORLD, PLAYS A VITAL ROLE IN FOSTERING FAITH, EDUCATION, AND SERVICE AMONG ITS MEMBERS. WHEN A NEW RELIEF SOCIETY PRESIDENCY IS APPOINTED, IT BRINGS A FRESH SET OF EYES AND HEARTS TO THESE RESPONSIBILITIES. THE PRESIDENCY TYPICALLY CONSISTS OF A PRESIDENT AND TWO COUNSELORS WHO WORK CLOSELY TOGETHER TO GUIDE THE ORGANIZATION'S ACTIVITIES, PROGRAMS, AND OUTREACH EFFORTS.

RESPONSIBILITIES AND IMPACT

THE NEW PRESIDENCY OFTEN REVIEWS PAST SUCCESSES AND CHALLENGES TO TAILOR THEIR APPROACH, ENSURING SERVICE EFFORTS MEET THE EVOLVING NEEDS OF THE COMMUNITY.

HOW THE NEW RELIEF SOCIETY PRESIDENCY SUPPORTS WOMEN'S GROWTH

ENHANCING SERVICE AND OUTREACH

THROUGH PARTNERSHIPS, THE PRESIDENCY CAN EXPAND THE SCOPE OF THEIR SERVICE PROJECTS, REACHING BEYOND THE CONGREGATION TO ASSIST IN COMMUNITY RELIEF EFFORTS, HUMANITARIAN AID, AND LOCAL CHARITABLE CAUSES. THIS COOPERATION ENRICHES THE RELIEF SOCIETY'S MISSION AND BROADENS ITS IMPACT.

TIPS FOR A SMOOTH TRANSITION TO NEW RELIEF SOCIETY LEADERSHIP

IN MANY WARDS AND BRANCHES, THE NEW RELIEF SOCIETY PRESIDENCY BECOMES A CATALYST FOR POSITIVE CHANGE—ENCOURAGING WOMEN TO DEVELOP TALENTS, TAKE ON LEADERSHIP ROLES, AND EXTEND KINDNESS AND ASSISTANCE TO THOSE AROUND THEM.
