Others however construe the final scene as a defeat and consider Jane to lose touch with reality and descend into insanity. Hedges, for instance, argues, that the protagonist is at the end defeated, totally mad and Suess constitutes that she is unable to distinguish fantasy from reality and asks how living in a state of psychosis [could] be considered triumphant in any way. Johnson again doubts whether Gilman herself actually fully comprehended the dimensions of her protagonist's madness. So what has really happened to the protagonist?
