WHAT IS THE CALIFORNIA STYLE MANUAL?

BEFORE JUMPING INTO THE NITTY-GRITTY OF CITATIONS, LET'S BRIEFLY EXPLORE WHAT THE CALIFORNIA STYLE MANUAL IS. PUBLISHED BY THE CALIFORNIA SUPREME COURT'S OFFICE OF THE REPORTER OF DECISIONS, THIS MANUAL OFFERS DETAILED INSTRUCTIONS ON HOW TO CITE CASES, STATUTES, REGULATIONS, AND OTHER LEGAL MATERIALS SPECIFICALLY FOR CALIFORNIA COURTS. IT EMPHASIZES CLARITY, UNIFORMITY, AND EASE OF READING.

UNLIKE THE BLUEBOOK, WHICH IS OFTEN MORE COMPLEX AND USED NATIONALLY, THE CALIFORNIA STYLE MANUAL PROVIDES A STREAMLINED APPROACH TAILORED TO CALIFORNIA'S LEGAL COMMUNITY. IT'S ESPECIALLY IMPORTANT FOR ANYONE PRACTICING IN STATE COURTS OR HANDLING MATTERS GOVERNED BY CALIFORNIA STATE LAW.

KEY FEATURES OF THE CALIFORNIA STYLE MANUAL CITATION CHEAT SHEET

CITING CALIFORNIA CASES

CASES ARE THE BACKBONE OF LEGAL WRITING. IN CALIFORNIA STYLE MANUAL CITATION, THE CASE NAME IS ITALICIZED OR UNDERLINED, FOLLOWED BY THE REPORTER VOLUME, REPORTER ABBREVIATION, FIRST PAGE OF THE CASE, AND PINPOINT PAGE IF APPLICABLE. THE COURT AND YEAR APPEAR IN PARENTHESES.

EXAMPLE:

PEOPLE V. SMITH (2020) 45 CAL.APP.5TH 123, 130

KEY POINTS:

- USE THE OFFICIAL CALIFORNIA REPORTER SERIES (CAL., CAL.APP., CAL.4TH, ETC.).
- ABBREVIATE PARTIES' NAMES WHEN APPROPRIATE, BUT RETAIN ESSENTIAL IDENTIFYING INFORMATION.
- ALWAYS INCLUDE THE COURT AND YEAR IF THE CASE IS UNPUBLISHED OR NOT WELL-KNOWN.

CITING STATUTES AND CODES

CALIFORNIA'S STATUTORY LAWS ARE CODIFIED IN VARIOUS CODES, SUCH AS THE PENAL CODE, CIVIL CODE, OR VEHICLE CODE.

THE CITATION FORMAT USUALLY INCLUDES THE CODE NAME (OFTEN ABBREVIATED), THE SECTION SYMBOL (§), AND THE SECTION NUMBER.

EXAMPLE:

CAL. PENAL CODE § 187 (WEST 2022)

TIPS:

- ALWAYS INCLUDE THE PUBLISHER'S NAME AND YEAR OF THE CODE EDITION YOU ARE CITING.
- USE THE OFFICIAL CODE ABBREVIATIONS RECOGNIZED BY THE CALIFORNIA STYLE MANUAL.
- FOR MULTIPLE SECTIONS, USE "§§" (DOUBLE SECTION SYMBOL).

CITING CALIFORNIA REGULATIONS

REGULATIONS ISSUED BY CALIFORNIA AGENCIES HAVE THEIR OWN CITATION RULES. TYPICALLY, THEY INCLUDE THE AGENCY NAME, REGULATION TITLE OR NAME, AND THE CODE OF REGULATIONS CITATION.

EXAMPLE:

CAL. CODE REGS., TIT. 15, § 3040 (2023)

REMEMBER:

- "CAL. CODE REGS." IS THE ABBREVIATION FOR THE CALIFORNIA CODE OF REGULATIONS.
- TITLE AND SECTION NUMBERS ARE ESSENTIAL.
- INCLUDE THE YEAR OF THE REGULATION IF AVAILABLE OR RELEVANT.

COMMON CITATION ELEMENTS EXPLAINED IN THE CHEAT SHEET

BEYOND IDENTIFYING HOW TO CITE CASES, STATUTES, AND REGULATIONS, THE CHEAT SHEET ALSO CLARIFIES OTHER COMMON CITATION ELEMENTS THAT FREQUENTLY TRIP UP LEGAL WRITERS.

SHORT FORM CITATIONS

ONCE YOU'VE CITED A CASE OR STATUTE IN FULL, CALIFORNIA STYLE MANUAL ALLOWS SHORT FORM CITATIONS TO AVOID REDUNDANCY.

EXAMPLE:

SMITH, SUPRA, 45 CAL.APP.5TH AT P. 130

THIS MEANS THE READER CAN REFER BACK TO THE FULL CITATION EARLIER IN THE DOCUMENT.

USE OF "ID." AND "SUPRA"

- **ID.** REFERS TO THE IMMEDIATELY PRECEDING CITATION, HELPFUL FOR CITING THE SAME SOURCE REPEATEDLY.
- **SUPRA** REFERS BACK TO A PREVIOUSLY CITED AUTHORITY BUT NOT THE ONE IMMEDIATELY PRECEDING IT.

THE CHEAT SHEET PROVIDES EXAMPLES TO ILLUSTRATE PROPER USAGE, ENSURING YOU DON'T MISUSE THESE TERMS AND CONFUSE YOUR READER.

PINPOINT CITATIONS (SPECIFIC PAGE REFERENCES)

PINPOINT CITATIONS DIRECT YOUR READER TO THE EXACT PAGE OR SECTION OF A SOURCE. IN CALIFORNIA STYLE MANUAL, THIS IS TYPICALLY DONE BY ADDING “AT P.” FOR CASES OR “AT §” FOR STATUTES.

EXAMPLE:

PEOPLE V. SMITH, SUPRA, 45 CAL.APP.5TH AT P. 130

INCLUDING PINPOINT CITATIONS ENHANCES CLARITY AND STRENGTHENS YOUR LEGAL ARGUMENTS BY ALLOWING PRECISE REFERENCES.

TIPS FOR USING THE CALIFORNIA STYLE MANUAL CITATION CHEAT SHEET EFFECTIVELY

A CHEAT SHEET IS ONLY AS GOOD AS HOW YOU USE IT. HERE ARE SOME TIPS TO MAXIMIZE YOUR EFFICIENCY WITH YOUR CALIFORNIA STYLE CITATION CHEAT SHEET:

COMMON MISTAKES TO AVOID

1. MIXING BLUEBOOK AND CALIFORNIA STYLE FORMATS IN THE SAME DOCUMENT.
2. FAILING TO INCLUDE THE COURT AND YEAR WHEN REQUIRED.
3. INCORRECT ABBREVIATION OF CASE NAMES OR CODES.
4. OMITTING PINPOINT CITATIONS WHERE NECESSARY.
5. USING “ID.” IMPROPERLY, ESPECIALLY WHEN THE IMMEDIATELY PRECEDING CITATION IS DIFFERENT.

AVOIDING THESE ERRORS WILL IMPROVE THE PROFESSIONALISM AND READABILITY OF YOUR WORK.
