Moreover, most importantly, they beckon us, always, to hear the thoughts of those seated at the intersection of art and ethics. I hope this volume will be a space for continued thought and dialogue, and a source of inspiration for the readers to return to the literary works to interrogate, resist, remember, and humanize.
