CONDUCT EXPECTED OF LICENSED PRACTITIONERS. IT IS AN ESSENTIAL COMPONENT OF THE LICENSURE PROCESS ADMINISTERED BY THE OHIO PHYSICAL THERAPY SECTION UNDER THE OHIO OCCUPATIONAL THERAPY, PHYSICAL THERAPY, AND ATHLETIC TRAINERS BOARD.

## PURPOSE AND IMPORTANCE

## HOW THE OHIO PHYSICAL THERAPY JURISPRUDENCE EXAM COMPARES NATIONALLY

WHILE MANY STATES REQUIRE JURISPRUDENCE EXAMS AS PART OF THE PHYSICAL THERAPY LICENSURE PROCESS, THE CONTENT AND EMPHASIS CAN VARY SIGNIFICANTLY. OHIO'S APPROACH REFLECTS A BALANCE BETWEEN LEGAL KNOWLEDGE AND PRACTICAL REGULATORY UNDERSTANDING TAILORED TO ITS UNIQUE LEGISLATIVE FRAMEWORK.

## STATE-SPECIFIC NUANCES
