THESE CODES ONLY SCRATCH THE SURFACE OF THE WIDE-RANGING CONDITIONS OCCUPATIONAL THERAPISTS MANAGE. THE ICD-10 classification includes thousands of codes, enabling detailed documentation of specific diagnoses that influence treatment plans.

INTEGRATING ICD-10 CODES INTO DOCUMENTATION AND REIMBURSEMENT

One of the challenges in occupational therapy is ensuring that ICD-10 codes are not only accurate but also compliant with payer requirements. Insurance companies and Medicare often scrutinize claims to verify that the diagnosis justifies the therapy provided.
