ANOTHER POINT OF CONTENTION INVOLVES TRANSPARENCY. WHILE SECURITY IS PARAMOUNT, SOME ARGUE THAT OVERLY RESTRICTIVE ACCESS TO ANSWER KEYS LIMITS OPPORTUNITIES FOR CANDIDATES TO REVIEW AND UNDERSTAND THEIR MISTAKES, POTENTIALLY AFFECTING LEARNING OUTCOMES.
