PERIOD 2: NETWORKS OF EXCHANGE, c. 1450–c. 1750

THIS ERA IS CHARACTERIZED BY SIGNIFICANT EUROPEAN MARITIME EXPLORATION AND THE ESTABLISHMENT OF NEW TRANSOCEANIC TRADE ROUTES. PERIOD 3: INDUSTRIALIZATION AND GLOBAL INTEGRATION, c. 1750–c. 1900

THE INDUSTRIAL REVOLUTION, ORIGINATING IN GREAT BRITAIN, FUNDAMENTALLY RESHAPED ECONOMIES, SOCIETIES, AND POLITICAL STRUCTURES WORLDWIDE. THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQs MIGHT TEST YOUR KNOWLEDGE OF INDUSTRIALIZATION, ITS SPREAD TO OTHER REGIONS, AND ITS CONSEQUENCES, INCLUDING URBANIZATION, NEW SOCIAL CLASSES, AND IDEOLOGIES LIKE LIBERALISM AND SOCIALISM. THIS PERIOD IS DEFINED BY TWO WORLD WARS, THE GREAT DEPRESSION, THE COLD WAR, AND THE PROCESS OF DECOLONIZATION. THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQs WILL LIKELY COVER THE CAUSES AND CONSEQUENCES OF WORLD WAR I AND WORLD WAR II, THE RISE OF TOTALITARIAN REGIMES, THE HOLOCAUST, AND THE NUCLEAR AGE. THE EMERGENCE OF NEW GLOBAL CHALLENGES LIKE ENVIRONMENTAL CONCERNS AND ECONOMIC GLOBALIZATION WILL ALSO BE RELEVANT.

COMMON THEMES AND SKILLS TESTED IN THE 2020 AP WORLD HISTORY MCQs

CONTINUITY AND CHANGE OVER TIME

THIS SKILL INVOLVES IDENTIFYING HOW SOCIETIES, INSTITUTIONS, TECHNOLOGIES, OR IDEAS HAVE EVOLVED OR REMAINED CONSISTENT ACROSS DIFFERENT HISTORICAL PERIODS. FOR THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQs, YOU MIGHT BE ASKED TO COMPARE A SPECIFIC ASPECT OF A SOCIETY IN 1450 WITH ITS STATE IN 1750, OR TO TRACE THE EVOLUTION OF A POLITICAL IDEOLOGY FROM THE ENLIGHTENMENT TO THE PRESENT DAY. UNDERSTANDING THE LONG-TERM IMPACT OF EVENTS AND PROCESSES IS KEY.

CAUSATION

THIS SKILL FOCUSES ON ANALYZING THE RELATIONSHIPS BETWEEN HISTORICAL EVENTS AND DEVELOPMENTS, UNDERSTANDING WHAT CAUSES THEM AND WHAT EFFECTS THEY HAVE. QUESTIONS ON THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQS MIGHT ASK ABOUT THE CAUSES OF THE AGRICULTURAL REVOLUTION, THE EFFECTS OF THE COLUMBIAN EXCHANGE, OR THE REASONS FOR THE DECLINE OF AN EMPIRE. YOU'LL NEED TO DISTINGUISH BETWEEN IMMEDIATE AND LONG-TERM CAUSES AND EFFECTS.

COMPARISON

THE ABILITY TO COMPARE AND CONTRAST DIFFERENT SOCIETIES, CULTURES, POLITICAL SYSTEMS, OR ECONOMIC STRUCTURES IS FUNDAMENTAL. THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQS MAY PRESENT STIMULI FROM DIFFERENT REGIONS OR TIME PERIODS AND ASK YOU TO IDENTIFY SIMILARITIES OR DIFFERENCES IN THEIR SOCIAL STRUCTURES, RESPONSES TO CHALLENGES, OR METHODS OF GOVERNANCE. CONTEXTUALIZATION

THIS SKILL REQUIRES PLACING HISTORICAL EVENTS, DEVELOPMENTS, OR PROCESSES WITHIN BROADER HISTORICAL PATTERNS AND STRUCTURES. WHEN ANALYZING A STIMULUS IN THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQS, YOU MIGHT NEED TO CONNECT IT TO LARGER TRENDS, SUCH AS THE GROWTH OF GLOBAL TRADE NETWORKS, THE SPREAD OF INDUSTRIALIZATION, OR THE IMPACT OF ENLIGHTENMENT IDEAS. UNDERSTANDING THE "BIG PICTURE" HELPS IN INTERPRETING SPECIFIC DETAILS.

ANALYSIS OF HISTORICAL SOURCES

STRATEGIES FOR TACKLING AP WORLD HISTORY MCQS

EFFECTIVE TIME MANAGEMENT

WITH ONLY 55 MINUTES FOR 55 QUESTIONS, TIME IS OF THE ESSENCE. IT IS CRUCIAL TO PACE YOURSELF. A GOOD STRATEGY IS TO AIM FOR AN AVERAGE OF ONE MINUTE PER QUESTION. IF YOU FIND YOURSELF SPENDING TOO MUCH TIME ON A SINGLE QUESTION, CONSIDER MARKING IT AND MOVING ON. YOU CAN ALWAYS RETURN TO IT LATER IF TIME PERMITS. AVOID GETTING BOGGED DOWN BY DIFFICULT QUESTIONS; IT IS BETTER TO ANSWER MORE QUESTIONS CORRECTLY THAN TO SPEND EXCESSIVE TIME ON A FEW.

ACTIVE READING AND ANNOTATION

WHEN PRESENTED WITH STIMULUS MATERIAL, READ IT ACTIVELY. UNDERLINE KEY TERMS, DATES, AND AUTHORIAL CLAIMS. FOR VISUAL SOURCES, NOTE THE KEY ELEMENTS AND ANY IMPLIED MESSAGES. WHEN READING THE QUESTIONS, PAY CLOSE ATTENTION TO KEYWORDS SUCH AS "EXCEPT," "MOST LIKELY," OR "BEST DESCRIBES." THESE WORDS CAN SIGNIFICANTLY ALTER THE MEANING OF THE QUESTION AND THE CORRECT ANSWER CHOICE.

ELIMINATION STRATEGY

FOR EACH QUESTION, CAREFULLY READ ALL THE ANSWER CHOICES. OFTEN, YOU CAN ELIMINATE TWO OR EVEN THREE INCORRECT OPTIONS IMMEDIATELY. THIS PROCESS OF ELIMINATION INCREASES YOUR CHANCES OF SELECTING THE CORRECT ANSWER, EVEN IF YOU ARE UNSURE. LOOK FOR CHOICES THAT ARE FACTUALLY INCORRECT, IRRELEVANT TO THE STIMULUS, OR MISINTERPRET THE HISTORICAL CONTEXT.

USING THE STIMULUS AS YOUR PRIMARY GUIDE

THE QUESTIONS IN THE 2020 AP WORLD HISTORY PRACTICE EXAM 1 MCQS ARE DIRECTLY LINKED TO THE PROVIDED STIMULUS. - **ORIGIN:** WHO CREATED THIS SOURCE, AND WHEN? WHAT IS THEIR ROLE OR POSITION?
- **PURPOSE:** WHY WAS THIS SOURCE CREATED? WHAT WAS THE AUTHOR TRYING TO ACHIEVE?
- **AUDIENCE:** TO WHOM WAS THIS SOURCE INTENDED? HOW MIGHT THIS INFLUENCE THE CONTENT?
