UNDERSTANDING THE HISTORICAL CONTEXT OF EXCISE TAXES

EXCISE TAXES WERE INTERNAL TAXES IMPOSED ON GOODS MANUFACTURED AND CONSUMED WITHIN THE COLONIES, DESIGNED BY THE BRITISH GOVERNMENT TO GENERATE REVENUE. THE ROLE OF THE EXCISE-MAN IN COLONIAL BOSTON

ANSWER: THE EXCISE-MAN WAS THE TAX COLLECTOR RESPONSIBLE FOR ENFORCING EXCISE TAXES. HE REPRESENTED BRITISH AUTHORITY AND WAS OFTEN MET WITH HOSTILITY IN BOSTON.

- **QUESTION:** HOW DID BOSTONIANS RESPOND TO THE EXCISE TAX?

ANSWER: BOSTONIANS RESISTED BY PROTESTING, REFUSING TO PAY, INTIMIDATING EXCISE-MEN, AND ORGANIZING BOYCOTTS, WHICH HEIGHTENED TENSIONS LEADING UP TO THE AMERICAN REVOLUTION.

- **QUESTION:** WHAT ECONOMIC EFFECTS DID THE EXCISE TAX HAVE ON BOSTON MERCHANTS?

ANSWER: THE TAX INCREASED COSTS FOR MERCHANTS, REDUCED TRADE VOLUMES, AND STRAINED RELATIONSHIPS WITH CUSTOMERS, CONTRIBUTING TO ECONOMIC HARDSHIP IN BOSTON.

ECONOMIC AND SOCIAL IMPACT ON BOSTONIANS
