STRUCTURAL COHERENCE AND NARRATIVE TECHNIQUE

A WELL-STRUCTURED NARRATIVE WITH COHERENT PLOT DEVELOPMENT AND EFFECTIVE PACING IS CRUCIAL FOR READER ENGAGEMENT. THE USE OF NARRATIVE TECHNIQUES SUCH AS POINT OF VIEW, FLASHBACKS, AND FORESHADOWING CAN ENRICH THE STORYTELLING AND MAKE A WORK MORE COMPELLING.
