UNDERSTANDING THE NC CONCEALED CARRY PERMIT

THE NC CONCEALED CARRY PERMIT, OFFICIALLY KNOWN AS THE NORTH CAROLINA CONCEALED HANDGUN PERMIT (CHP), ALLOWS QUALIFIED RESIDENTS TO CARRY A CONCEALED HANDGUN LEGALLY IN PUBLIC. ISSUED BY THE COUNTY SHERIFF'S OFFICE, THE PERMIT PROCESS INVOLVES MEETING ELIGIBILITY CRITERIA SUCH AS AGE, RESIDENCY, BACKGROUND CHECKS, AND COMPLETION OF A FIREARMS SAFETY TRAINING COURSE. THE PERMIT IS VALID FOR FIVE YEARS AND MUST BE RENEWED BEFORE EXPIRATION. PURPOSE AND BENEFITS OF THE PERMIT

THE PERMIT ALLOWS INDIVIDUALS TO CARRY A CONCEALED HANDGUN FOR PERSONAL PROTECTION WITHIN THE STATE AND IN OTHER STATES WITH RECIPROCITY AGREEMENTS. IT ALSO HELPS ENSURE THAT PERMIT HOLDERS UNDERSTAND FIREARM LAWS AND SAFETY PRACTICES, WHICH ENHANCES PUBLIC SAFETY AND RESPONSIBLE GUN OWNERSHIP.

FORMAT AND CONTENT OF NC CONCEALED CARRY TEST

ANSWER: PRESENT THE PERMIT AND IDENTIFICATION IMMEDIATELY UPON REQUEST.

4. **QUESTION:** IS IT LEGAL TO CARRY A CONCEALED HANDGUN WHILE UNDER THE INFLUENCE OF ALCOHOL?

ANSWER: NO, IT IS ILLEGAL TO CARRY A FIREARM WHILE IMPAIRED BY ALCOHOL OR DRUGS.

5. **QUESTION:** HOW SHOULD A CONCEALED HANDGUN BE STORED WHEN NOT CARRIED?

ANSWER: IT SHOULD BE STORED UNLOADED AND LOCKED IN A SECURE LOCATION INACCESSIBLE TO UNAUTHORIZED PERSONS.

LEGAL REQUIREMENTS AND RESTRICTIONS IN NORTH CAROLINA

PLACES WHERE CONCEALED CARRY IS RESTRICTED

- SCHOOLS AND EDUCATIONAL PROPERTY
- COURTHOUSES AND GOVERNMENT BUILDINGS
- STATE AND LOCAL GOVERNMENT MEETINGS
- PRIVATE PROPERTY WHERE FIREARMS ARE PROHIBITED

- FEDERAL BUILDINGS AND POST OFFICES

LEGAL USE OF FORCE AND SELF-DEFENSE

NORTH CAROLINA LAW PERMITS THE USE OF DEADLY FORCE IN SELF-DEFENSE OR DEFENSE OF OTHERS UNDER SPECIFIC CIRCUMSTANCES, SUCH AS IMMINENT THREAT OF DEATH OR SERIOUS BODILY HARM. UNDERSTANDING THESE LEGAL BOUNDARIES IS CRITICAL FOR RESPONSIBLE CONCEALED CARRY.
