COMMUTATIVE PROPERTY

ASSOCIATIVE PROPERTY

THE ASSOCIATIVE PROPERTY INDICATES THAT THE WAY NUMBERS ARE GROUPED IN ADDITION OR MULTIPLICATION DOES NOT CHANGE THEIR SUM OR PRODUCT. THIS PROPERTY IS LIMITED TO ADDITION AND MULTIPLICATION.

- ADDITION EXAMPLE: $(A + B) + C = A + (B + C)$
- MULTIPLICATION EXAMPLE: $(A \times B) \times C = A \times (B \times C)$

DISTRIBUTIVE PROPERTY

THE DISTRIBUTIVE PROPERTY CONNECTS MULTIPLICATION AND ADDITION, ALLOWING ONE TO MULTIPLY A NUMBER BY A SUM BY MULTIPLYING EACH ADDEND SEPARATELY AND THEN ADDING THE PRODUCTS.

- EXAMPLE: $A \times (B + C) = (A \times B) + (A \times C)$

IDENTITY PROPERTY

THE IDENTITY PROPERTY REFERS TO THE EXISTENCE OF AN ELEMENT (IDENTITY ELEMENT) IN ADDITION OR MULTIPLICATION THAT LEAVES ANY NUMBER UNCHANGED WHEN COMBINED WITH IT.

- ADDITIVE IDENTITY: $A + 0 = A$
- MULTIPLICATIVE IDENTITY: $A \times 1 = A$

INVERSE PROPERTY

THE INVERSE PROPERTY INVOLVES THE EXISTENCE OF AN INVERSE ELEMENT THAT, WHEN COMBINED WITH A NUMBER UNDER ADDITION OR MULTIPLICATION, RESULTS IN THE IDENTITY ELEMENT.

- ADDITIVE INVERSE: $A + (-A) = 0$
- MULTIPLICATIVE INVERSE: $A \times (1/A) = 1$, WHERE $A \neq 0$

How to Identify Properties Correctly

ANSWER: IDENTITY PROPERTY OF ADDITION.

- **QUESTION:** NAME THE PROPERTY THAT JUSTIFIES $a \times 1 = a$.

ANSWER: IDENTITY PROPERTY OF MULTIPLICATION.

APPLICATIONS BEYOND MATHEMATICS
