• MORAL RESPONSIBILITY: THE UNITED STATES SAW ITSELF AS A MORAL BEACON, TASKED WITH SPREADING CIVILIZATION AND UPLIFTING OTHER NATIONS.

THIS APPROACH MARKED A SHIFT FROM PURELY PRAGMATIC OR ECONOMIC FOREIGN POLICY TO ONE GUIDED BY ETHICAL CONSIDERATIONS, COMBINING IDEALISM WITH STRATEGIC INTERESTS.

# IMPLEMENTATION DURING WOODROW WILSON'S PRESIDENCY

Woodrow Wilson's presidency (1913-1921) is most closely associated with the practical application of missionary diplomacy. Wilson, a progressive reformer, infused his foreign policy with the ideals of democracy and moral righteousness, shaping U.S. interactions with other countries during his time in office.

#### POLICY IN LATIN AMERICA

- DOMINICAN REPUBLIC: WILSON AUTHORIZED MILITARY INTERVENTION TO RESTORE ORDER AND PROMOTE DEMOCRATIC PEROPMS

THESE ACTIONS UNDERSCORED THE ADMINISTRATION'S WILLINGNESS TO USE AMERICAN POWER TO SHAPE POLITICAL OUTCOMES IN THE WESTERN HEMISPHERE BASED ON MORAL AND DEMOCRATIC CRITERIA.

#### DIPLOMATIC STRATEGIES AND CHALLENGES

Wilson's missionary diplomacy also faced significant challenges. The insistence on moral standards complicated relations with countries that had complex political realities. Additionally, interventions sometimes fostered resentment and perceptions of American Imperialism. Despite these obstacles, Wilson's policy reflected a broader trend of idealistic internationalism that influenced U.S. diplomacy during the Early 20th century.

# IMPACT ON U.S.-LATIN AMERICAN RELATIONS

## CRITICISM AND LEGACY OF MISSIONARY DIPLOMACY

While missionary diplomacy sought to promote noble ideals, it attracted substantial criticism both domestically and internationally. Critics argued that the policy was a guise for American imperialism and interventionism, often undermining the very democratic principles it claimed to support.

- ACCUSATIONS OF HYPOCRISY: SOME COMMENTATORS NOTED THE CONTRADICTION BETWEEN ADVOCATING DEMOCRACY ABROAD WHILE TOLERATING RACIAL SEGREGATION AND INEQUALITY AT HOME.
