THESE RATINGS PROVIDE VOTERS WITH A CLEAR INDICATION OF A CANDIDATE'S ALIGNMENT WITH THE NRA'S MISSION TO PROTECT SECOND AMENDMENT RIGHTS.

RATING SCALE EXPLAINED

THE NRA USES A LETTER-GRADE SYSTEM TO RATE CANDIDATES, WHICH TYPICALLY RANGES FROM A+ TO F. EACH GRADE REFLECTS THE CANDIDATE'S POSITION ON GUN LEGISLATION:

- **A+ AND A:** STRONG SUPPORT FOR GUN RIGHTS AND CONSISTENT VOTING RECORDS IN FAVOR OF THE SECOND AMENDMENT.
- **B AND C:** MIXED RECORDS OR MODERATE SUPPORT, INDICATING SOME ALIGNMENT WITH NRA PRINCIPLES BUT OCCASIONAL OPPOSITION TO GUN RIGHTS.
- **D AND F:** OPPOSE GUN RIGHTS, SUPPORT RESTRICTIVE GUN CONTROL LAWS, OR HAVE POOR VOTING RECORDS ON FIREARMS LEGISLATION.

THIS SYSTEM ENABLES VOTERS TO QUICKLY ASSESS WHICH CANDIDATES ARE MOST LIKELY TO UPHOLD PRO-GUN POLICIES.

FACTORS INFLUENCING RATINGS

SEVERAL FACTORS INFLUENCE A CANDIDATE'S NRA RATING, INCLUDING:

- VOTING RECORD ON KEY GUN-RELATED BILLS.
- PUBLIC STATEMENTS AND POSITIONS ON FIREARMS LEGISLATION.
- RESPONSES TO NRA QUESTIONNAIRES AND SURVEYS.
- ENDORSEMENTS OR OPPOSITION FROM GUN RIGHTS ADVOCACY GROUPS.

KEY ISSUES COVERED IN THE GUIDE

NRA LOCAL CHAPTERS AND AFFILIATED GROUPS FREQUENTLY PROVIDE THE VOTERS GUIDE DURING MEETINGS AND EVENTS, OFFERING OPPORTUNITIES FOR VOTERS TO DISCUSS THE CONTENT AND ASK QUESTIONS ABOUT CANDIDATES AND ISSUES.
