## OVERVIEW OF THE SSVF PROGRAM

THE SUPPORTIVE SERVICES FOR VETERAN FAMILIES (SSVF) PROGRAM IS A CRITICAL INITIATIVE DESIGNED TO PROVIDE RAPID REHOUSING AND HOMELESSNESS PREVENTION SERVICES TO VERY LOW-INCOME VETERAN FAMILIES. IN 2023, THE PROGRAM CONTINUES TO FOCUS ON REDUCING VETERAN HOMELESSNESS BY OFFERING TAILORED SUPPORT AIMED AT STABILIZING HOUSING AND PROMOTING SELF-SUFFICIENCY. FUNDED BY THE U.S. DEPARTMENT OF VETERANS AFFAIRS (VA), THE SSVF PROGRAM PARTNERS WITH COMMUNITY-BASED ORGANIZATIONS ACROSS THE COUNTRY TO DELIVER COMPREHENSIVE ASSISTANCE. THIS PROGRAM IS RECOGNIZED FOR ITS FLEXIBLE AND VETERAN-CENTERED APPROACH, ADDRESSING IMMEDIATE HOUSING NEEDS AND LONG-TERM STABILITY THROUGH A VARIETY OF SERVICES.

## PURPOSE AND GOALS OF SSVF

THE PRIMARY GOAL OF THE SSVF PROGRAM IS TO PREVENT HOMELESSNESS AMONG VETERANS AND THEIR FAMILIES OR QUICKLY MOVE THOSE EXPERIENCING HOMELESSNESS INTO STABLE HOUSING. THIS IS ACHIEVED THROUGH CASE MANAGEMENT, FINANCIAL ASSISTANCE, AND CONNECTIONS TO COMMUNITY RESOURCES. EMPHASIS IS PLACED ON IMPROVING VETERANS' QUALITY OF LIFE BY SUPPORTING THEIR HOUSING STABILITY AND INCREASING ACCESS TO HEALTHCARE, EMPLOYMENT, AND OTHER ESSENTIAL SERVICES. THE 2023 PROGRAM GUIDE HIGHLIGHTS A CONTINUED COMMITMENT TO THESE GOALS WHILE ADAPTING TO EVOLVING VETERAN NEEDS AND HOUSING MARKET CHALLENGES.

## PROGRAM ADMINISTRATION AND FUNDING

THE SSVF PROGRAM IS ADMINISTERED BY THE VA BUT IMPLEMENTED THROUGH GRANTS AWARDED TO NONPROFIT ORGANIZATIONS AND CONSUMER COOPERATIVES SPECIALIZING IN VETERAN SERVICES. THESE GRANTEEES ARE RESPONSIBLE FOR DELIVERING DIRECT ASSISTANCE, CONDUCTING OUTREACH, AND COORDINATING WITH OTHER FEDERAL AND LOCAL AGENCIES. FUNDING LEVELS AND GRANT CYCLES IN 2023 REFLECT ONGOING FEDERAL SUPPORT AIMED AT SUSTAINING AND EXPANDING THE PROGRAM'S REACH NATIONWIDE.

# ELIGIBILITY CRITERIA FOR SSVF ASSISTANCE

UNDERSTANDING ELIGIBILITY IS CRUCIAL FOR VETERANS AND THEIR FAMILIES SEEKING SUPPORT THROUGH THE SSVF PROGRAM. IN 2023, THE CRITERIA REMAIN FOCUSED ON IDENTIFYING VERY LOW-INCOME VETERAN HOUSEHOLDS WHO ARE AT RISK OF OR CURRENTLY EXPERIENCING HOMELESSNESS. COMPLIANCE WITH THESE STANDARDS ENSURES THAT ASSISTANCE IS DIRECTED TO THOSE MOST IN NEED.

## WHO QUALIFIES FOR THE PROGRAM?

ELIGIBILITY REQUIREMENTS INCLUDE THE FOLLOWING KEY FACTORS:

- VETERAN STATUS VERIFICATION, INCLUDING ACTIVE DUTY OR DISCHARGE STATUS AS DEFINED BY VA GUIDELINES.
- HOUSEHOLD INCOME MUST BE BELOW 50% OF THE AREA MEDIAN INCOME (AMI) TO QUALIFY AS VERY LOW-INCOME.
- INDIVIDUALS OR FAMILIES FACING LITERAL HOMELESSNESS, IMMINENT RISK OF HOMELESSNESS, OR THOSE RECENTLY HOMELESS BUT NOW IN PERMANENT HOUSING.
- PRIORITY IS GIVEN TO HOMELESS VETERANS WITH DISABILITIES, INCLUDING THOSE WITH CHRONIC HEALTH CONDITIONS OR MENTAL HEALTH CHALLENGES.

THESE CRITERIA ENSURE THAT SSVF RESOURCES ARE EFFICIENTLY ALLOCATED TO VETERANS AND THEIR FAMILIES WHO REQUIRE IMMEDIATE HOUSING SUPPORT AND RELATED SERVICES.

## DOCUMENTATION AND VERIFICATION PROCESS

APPLICANTS MUST PROVIDE DOCUMENTATION PROVING VETERAN STATUS, HOUSEHOLD INCOME, AND HOUSING SITUATION. THE 2023 GUIDE EMPHASIZES THE IMPORTANCE OF ACCURATE AND TIMELY SUBMISSION OF REQUIRED DOCUMENTS TO EXPEDITE THE APPLICATION PROCESS. VERIFICATION MAY INCLUDE DISCHARGE PAPERS (DD FORM 214), INCOME STATEMENTS, AND PROOF OF HOMELESSNESS OR HOUSING INSTABILITY.

## TYPES OF SUPPORTIVE SERVICES OFFERED

THE SSVF PROGRAM DELIVERS A WIDE RANGE OF SUPPORTIVE SERVICES DESIGNED TO ASSIST VETERANS IN MAINTAINING OR OBTAINING STABLE HOUSING. IN 2023, THESE SERVICES CONTINUE TO EVOLVE TO ADDRESS THE MULTIFACETED NEEDS OF VETERAN FAMILIES.

### RAPID REHOUSING ASSISTANCE

RAPID REHOUSING IS A CORE COMPONENT OF THE SSVF PROGRAM. IT PROVIDES SHORT-TERM RENTAL ASSISTANCE AND HOUSING RELOCATION SERVICES TO HELP HOMELESS VETERANS QUICKLY SECURE PERMANENT HOUSING. THIS INCLUDES HELP WITH SECURITY DEPOSITS, FIRST MONTH'S RENT, AND UTILITY SETUP FEES.

### HOMELESSNESS PREVENTION SERVICES

FOR VETERANS AT RISK OF LOSING THEIR CURRENT HOUSING, THE SSVF PROGRAM OFFERS PREVENTION SERVICES SUCH AS FINANCIAL COUNSELING, MEDIATION WITH LANDLORDS, AND EMERGENCY FINANCIAL AID. THESE MEASURES AIM TO STABILIZE HOUSING SITUATIONS AND PREVENT ENTRY INTO HOMELESSNESS.

## CASE MANAGEMENT AND SUPPORTIVE SERVICES

COMPREHENSIVE CASE MANAGEMENT IS PROVIDED TO CONNECT VETERANS WITH OTHER BENEFITS AND SERVICES, INCLUDING HEALTHCARE, EMPLOYMENT ASSISTANCE, LEGAL AID, AND SUBSTANCE ABUSE TREATMENT. THE 2023 PROGRAM GUIDE HIGHLIGHTS AN INCREASED FOCUS ON PERSONALIZED SUPPORT PLANS TAILORED TO EACH VETERAN'S UNIQUE CIRCUMSTANCES.

## OTHER ASSISTANCE PROGRAMS

ADDITIONAL SUPPORTIVE SERVICES UNDER THE SSVF UMBRELLA MAY INCLUDE:

- TRANSPORTATION ASSISTANCE
- CHILDCARE RESOURCES
- LIFE SKILLS TRAINING
- CREDIT REPAIR AND BUDGETING EDUCATION

THESE SERVICES COLLECTIVELY ENHANCE THE ABILITY OF VETERANS AND THEIR FAMILIES TO ACHIEVE LONG-TERM HOUSING STABILITY AND SELF-SUFFICIENCY.

## APPLICATION AND ENROLLMENT PROCESS

THE PROCESS OF APPLYING FOR THE SSVF PROGRAM IN 2023 INVOLVES SEVERAL STRUCTURED STEPS DESIGNED TO ASSESS NEEDS AND PROVIDE TIMELY ASSISTANCE. UNDERSTANDING THESE STEPS HELPS VETERANS AND SERVICE PROVIDERS NAVIGATE THE SYSTEM MORE EFFICIENTLY.

## INITIAL CONTACT AND INTAKE

VETERANS INTERESTED IN SSVF ASSISTANCE MUST FIRST CONTACT A LOCAL SSVF PROVIDER ORGANIZATION. DURING INTAKE, THE PROVIDER COLLECTS INFORMATION ABOUT THE VETERAN'S HOUSING STATUS, INCOME, AND FAMILY COMPOSITION. THIS STAGE DETERMINES INITIAL ELIGIBILITY AND IDENTIFIES IMMEDIATE NEEDS.

## ASSESSMENT AND SERVICE PLANNING

ONCE ELIGIBILITY IS CONFIRMED, A CASE MANAGER WORKS WITH THE VETERAN TO DEVELOP A SERVICE PLAN. THIS PLAN OUTLINES THE TYPE AND DURATION OF ASSISTANCE REQUIRED, FOCUSING ON HOUSING SOLUTIONS AND SUPPORTIVE SERVICES TAILORED TO THE VETERAN'S CIRCUMSTANCES.

## DOCUMENTATION SUBMISSION AND APPROVAL

APPLICANTS SUBMIT ALL NECESSARY DOCUMENTATION FOR VERIFICATION. AFTER REVIEW, THE SSVF PROVIDER APPROVES THE VETERAN'S ENROLLMENT AND BEGINS DELIVERING THE AGREED-UPON SERVICES. THE 2023 GUIDE STRESSES THE IMPORTANCE OF MAINTAINING COMMUNICATION WITH PROVIDERS THROUGHOUT THIS PHASE TO ADDRESS ANY ISSUES PROMPTLY.

## ONGOING MONITORING AND FOLLOW-UP

SSVF PROVIDERS CONTINUE TO MONITOR ENROLLED VETERANS' PROGRESS, ADJUSTING SERVICES AS NEEDED TO ENSURE HOUSING

STABILITY. FOLLOW-UP INCLUDES PERIODIC REASSESSMENTS AND COORDINATION WITH OTHER COMMUNITY RESOURCES TO SUPPORT SUSTAINED SUCCESS.

## UPDATES AND CHANGES IN THE 2023 PROGRAM

THE SSVF PROGRAM GUIDE 2023 INCLUDES SEVERAL IMPORTANT UPDATES REFLECTING CHANGES IN FEDERAL POLICIES, FUNDING PRIORITIES, AND PROGRAM OPERATIONS DESIGNED TO ENHANCE SERVICE DELIVERY AND VETERAN OUTCOMES.

### ENHANCED DATA REPORTING REQUIREMENTS

NEW DATA REPORTING STANDARDS INTRODUCED IN 2023 AIM TO IMPROVE PROGRAM TRANSPARENCY AND EFFECTIVENESS. SSVF PROVIDERS ARE REQUIRED TO SUBMIT MORE DETAILED OUTCOME DATA TO THE VA, INCLUDING HOUSING RETENTION RATES AND SERVICE UTILIZATION STATISTICS.

### UPDATED ELIGIBILITY FLEXIBILITIES

THE 2023 GUIDE OUTLINES ADJUSTMENTS TO ELIGIBILITY CRITERIA TO ACCOMMODATE VETERANS EXPERIENCING NON-TRADITIONAL FORMS OF HOUSING INSTABILITY, SUCH AS COUCH SURFING OR LIVING IN MOTELS. THESE FLEXIBILITIES HELP ENSURE THAT A BROADER RANGE OF VETERANS CAN ACCESS ASSISTANCE.

## TIPS FOR MAXIMIZING BENEFITS FROM SSVF

TO FULLY BENEFIT FROM THE SSVF PROGRAM, VETERANS AND SERVICE PROVIDERS SHOULD CONSIDER SEVERAL STRATEGIC APPROACHES OUTLINED IN THE 2023 GUIDE. THESE BEST PRACTICES PROMOTE EFFECTIVE USE OF PROGRAM RESOURCES AND IMPROVED OUTCOMES.

### MAINTAIN CLEAR AND ACCURATE DOCUMENTATION

ENSURING ALL REQUIRED DOCUMENTS ARE CURRENT AND COMPLETE HELPS STREAMLINE THE APPLICATION AND APPROVAL PROCESS. VETERANS SHOULD KEEP COPIES OF DISCHARGE PAPERS, INCOME STATEMENTS, AND HOUSING VERIFICATIONS READILY AVAILABLE.

### ENGAGE ACTIVELY WITH CASE MANAGERS

BUILDING A STRONG RELATIONSHIP WITH CASE MANAGERS ENABLES PERSONALIZED SERVICE PLANNING AND TIMELY ADJUSTMENTS TO SUPPORT NEEDS. OPEN COMMUNICATION IS ESSENTIAL FOR ADDRESSING CHALLENGES AND IDENTIFYING ADDITIONAL RESOURCES.

## UTILIZE COMPLEMENTARY COMMUNITY RESOURCES

SSVF SERVICES WORK BEST WHEN INTEGRATED WITH OTHER SUPPORT SYSTEMS. VETERANS SHOULD SEEK OUT COMPLEMENTARY PROGRAMS FOR HEALTHCARE, EMPLOYMENT, AND LEGAL ASSISTANCE TO ENHANCE OVERALL STABILITY AND WELL-BEING.

## PLAN FOR LONG-TERM STABILITY

WHILE SSVF PROVIDES CRITICAL SHORT-TERM ASSISTANCE, VETERANS SHOULD FOCUS ON LONG-TERM HOUSING SOLUTIONS AND FINANCIAL INDEPENDENCE. PARTICIPATING IN LIFE SKILLS TRAINING AND FINANCIAL LITERACY PROGRAMS OFFERED THROUGH OR ALONGSIDE SSVF CAN SIGNIFICANTLY CONTRIBUTE TO SUSTAINED SUCCESS.
