ASSIMILATION POLICIES

The act authorized the President to survey tribal lands and allocate parcels to individual Native Americans, typically ranging from 40 to 160 acres per person. Excess lands remaining after allotment were opened to non-Native settlers, often leading to significant loss of tribal landholdings.

ALLOCATION OF LAND ALLOTMENTS

CITIZENSHIP AND LEGAL CHANGES

THE DAWES ACT ALSO PROVIDED A PATHWAY TO U.S. CITIZENSHIP FOR NATIVE AMERICANS WHO ACCEPTED ALLOTMENTS AND ADOPTED "CIVILIZED" LIFESTYLES.
