#### THE GREAT COMPROMISE

THE GREAT COMPROMISE, ALSO KNOWN AS THE CONNECTICUT COMPROMISE, WAS A PIVOTAL AGREEMENT REACHED DURING THE CONSTITUTIONAL CONVENTION OF 1787. IT RESOLVED A SERIOUS DISPUTE BETWEEN LARGE AND SMALL STATES REGARDING LEGISLATIVE REPRESENTATION. LARGER STATES FAVORED THE VIRGINIA PLAN, WHICH PROPOSED REPRESENTATION BASED ON POPULATION, WHILE SMALLER STATES SUPPORTED THE NEW JERSEY PLAN, ADVOCATING EQUAL REPRESENTATION FOR ALL STATES.

#### BACKGROUND AND CONFLICT

BEFORE THE COMPROMISE, THE DEBATE THREATENED TO STALL THE ENTIRE CONVENTION. LARGE STATES SOUGHT PROPORTIONAL REPRESENTATION TO REFLECT THEIR POPULATION ADVANTAGE, WHILE SMALL STATES FEARED DOMINATION WITHOUT EQUAL REPRESENTATION. THE DISAGREEMENT CENTERED ON HOW TO STRUCTURE THE NEW NATIONAL LEGISLATURE TO BE FAIR TO ALL PARTIES

#### DETAILS OF THE COMPROMISE

THE GREAT COMPROMISE CREATED A BICAMERAL LEGISLATURE, CONSISTING OF TWO HOUSES:

- THE HOUSE OF REPRESENTATIVES: REPRESENTATION BASED ON STATE POPULATION, FAVORING LARGER STATES.
- THE SENATE: EQUAL REPRESENTATION WITH TWO SENATORS PER STATE, SATISFYING SMALLER STATES.

THIS DUAL SYSTEM BALANCED POWER BETWEEN STATES OF DIFFERING SIZES AND ENSURED THAT BOTH POPULATION AND STATE SOVEREIGNTY WERE RESPECTED IN THE LEGISLATIVE PROCESS.

#### THE THREE-FIFTHS COMPROMISE

THE THREE-FIFTHS COMPROMISE ADDRESSED HOW ENSLAVED INDIVIDUALS WOULD BE COUNTED WHEN DETERMINING A STATE'S POPULATION FOR REPRESENTATION AND TAXATION PURPOSES. THIS COMPROMISE WAS A CONTENTIOUS ISSUE THAT REFLECTED DEEP DIVISIONS BETWEEN NORTHERN AND SOUTHERN STATES.

#### ISSUES LEADING TO THE COMPROMISE

Southern states wanted enslaved people fully counted to increase their representation in the House of Representatives, while Northern states, where slavery was less prevalent, opposed this. The disagreement threatened to derail the formation of the Constitution.

#### TERMS OF THE THREE-FIFTHS COMPROMISE

THE DELEGATES AGREED THAT EACH ENSLAVED PERSON WOULD BE COUNTED AS THREE-FIFTHS OF A PERSON FOR BOTH REPRESENTATION AND TAXATION. THIS COMPROMISE GAVE SOUTHERN STATES MORE POLITICAL POWER THAN IF SLAVES HAD BEEN EXCLUDED ENTIRELY BUT LESS THAN IF THEY HAD BEEN FULLY COUNTED.

#### THE COMMERCE AND SLAVE TRADE COMPROMISE

This compromise dealt with Congress's power to regulate commerce and the contentious issue of the slave trade. It was essential for reconciling economic interests between Northern and Southern states.

#### COMMERCE REGULATION DISPUTES

NORTHERN STATES WANTED CONGRESS TO HAVE BROAD AUTHORITY TO REGULATE INTERSTATE AND INTERNATIONAL TRADE, INCLUDING IMPOSING TARIFFS. SOUTHERN STATES FEARED THAT SUCH POWER WOULD BE USED TO RESTRICT THEIR AGRICULTURAL EXPORTS AND THE IMPORTATION OF ENSLAVED PEOPLE.

#### COMPROMISE TERMS

The agreement allowed Congress to regulate interstate and international commerce but prohibited any laws banning the slave trade for at least twenty years after the Constitution's ratification (until 1808). Additionally, Congress could impose tariffs on imports but not exports, protecting Southern agricultural interests.

### ADDITIONAL KEY COMPROMISES

BEYOND THE MAJOR COMPROMISES, SEVERAL OTHER AGREEMENTS WERE CRUCIAL IN THE FORMATION OF THE CONSTITUTION, REFLECTING THE COMPLEX NEGOTIATIONS AMONG DELEGATES.

#### **ELECTORAL COLLEGE COMPROMISE**

THE METHOD OF ELECTING THE PRESIDENT WAS SETTLED BY CREATING THE ELECTORAL COLLEGE, BALANCING BETWEEN DIRECT POPULAR ELECTION AND CONGRESSIONAL SELECTION. THIS SYSTEM WAS DESIGNED TO PROVIDE A BUFFER AGAINST DIRECT DEMOCRACY WHILE GIVING SMALLER STATES A VOICE.

#### SLAVE TRADE AND FUGITIVE SLAVE CLAUSES

In addition to the Commerce Compromise, the Constitution included provisions requiring the return of escaped enslaved individuals to their owners and delayed restrictions on the international slave trade, further illustrating the contentious nature of slavery in the New Nation.

#### BALANCING FEDERAL AND STATE POWERS

THE CONSTITUTION ALSO BALANCED POWERS BETWEEN THE FEDERAL GOVERNMENT AND STATES, ESTABLISHING A FEDERAL SYSTEM THAT ALLOWED FOR SHARED SOVEREIGNTY—AN ESSENTIAL COMPROMISE TO SATISFY STATES WARY OF CENTRAL AUTHORITY.
