HISTORICAL CONTEXT OF THE DECLARATION OF INDEPENDENCE

THE CONTINENTAL CONGRESS SERVED AS THE GOVERNING BODY REPRESENTING THE COLONIES DURING THE REVOLUTIONARY PERIOD. RIGHT TO REVOLUTION

THE DECLARATION LEGITIMIZES REVOLUTION BY STATING THAT PEOPLE MAY OVERTHROW A GOVERNMENT THAT VIOLATES THEIR RIGHTS. THIS JUSTIFICATION WAS PIVOTAL IN RALLYING SUPPORT FOR INDEPENDENCE AND REMAINS AN INFLUENTIAL CONCEPT IN DEMOCRATIC GOVERNANCE WORLDWIDE.

AUTHORSHIP AND DRAFTING PROCESS

THE COMMITTEE OF FIVE, CONSISTING OF JEFFERSON, JOHN ADAMS, BENJAMIN FRANKLIN, ROGER SHERMAN, AND ROBERT LIVINGSTON, REVIEWED AND MODIFIED THE DRAFT. THE REVISIONS MADE BY THE COMMITTEE AND LATER BY THE CONTINENTAL CONGRESS ENSURED THE DOCUMENT'S CLARITY, UNITY, AND POLITICAL IMPACT.

ADOPTION ON JULY 4, 1776

AFTER DEBATE AND EDITING, THE DECLARATION WAS OFFICIALLY ADOPTED BY THE CONTINENTAL CONGRESS ON JULY 4, 1776. THIS DATE IS CELEBRATED ANNUALLY AS INDEPENDENCE DAY, COMMEMORATING THE COLONIES' FORMAL ASSERTION OF
