- PUBLIC RECORDS DATABASES
- ANONYMOUS TIPS OR EYEWITNESS ACCOUNTS
- SOCIAL MEDIA POSTS AND VIDEOS

HOWEVER, THE RELIABILITY OF THESE SOURCES VARIES WIDELY, AND MANY CLAIMS REMAIN UNSUBSTANTIATED WITHIN THE REDDIT COMMUNITY ITSELF.

VERIFICATION AND CREDIBILITY OF ONLINE INFORMATION

GIVEN THE PROLIFERATION OF INFORMATION ON REDDIT AND OTHER PLATFORMS, VERIFYING THE ACCURACY OF CLAIMS ABOUT TYRE NICHOLS' CRIMINAL HISTORY IS PARAMOUNT. THE PROCESS INVOLVES CROSS-REFERENCING PUBLIC RECORDS, CONSULTING CREDIBLE NEWS REPORTS, AND UNDERSTANDING THE LIMITATIONS OF ONLINE DATA.
