UNDERSTANDING WISCONSIN GARNISHMENT LAWS

WISCONSIN GARNISHMENT LAWS REGULATE THE PROCESS BY WHICH CREDITORS CAN COLLECT DEBTS BY WITHHOLDING A PORTION OF A DEBTOR'S WAGES OR BANK ACCOUNTS. THESE LAWS ARE DESIGNED TO BALANCE THE INTERESTS OF CREDITORS SEEKING REPAYMENT AND DEBTORS NEEDING TO RETAIN SUFFICIENT INCOME FOR LIVING EXPENSES. THE STATE FOLLOWS SPECIFIC GUIDELINES THAT LIMIT THE AMOUNT OF DISPOSABLE EARNINGS SUBJECT TO GARNISHMENT, ENSURING THAT DEBTORS ARE NOT LEFT DESTITUTE. LEGAL LIMITS ON WAGE GARNISHMENT

HOW TO COMPLETE THE WISCONSIN GARNISHMENT EXEMPTION WORKSHEET

TYPES OF INCOME AND EXEMPTIONS

INCOME SUBJECT TO GARNISHMENT

THIS INCLUDES REGULAR PAYCHECKS AS WELL AS OVERTIME PAY, UNLESS SPECIFICALLY EXEMPTED BY LAW. CERTAIN GOVERNMENT BENEFITS AND RETIREMENT INCOME MAY ALSO BE GARNISHABLE DEPENDING ON CIRCUMSTANCES AND FEDERAL PROTECTIONS.

EXEMPTIONS AND PROTECTED INCOME

WISCONSIN LAW PROVIDES EXEMPTIONS AIMED AT PRESERVING A MINIMUM STANDARD OF LIVING FOR DEBTORS. THESE INCLUDE:

- BASIC EXEMPTION AMOUNTS BASED ON THE FEDERAL MINIMUM WAGE MULTIPLIED BY A SPECIFIED FACTOR.
- ADDITIONAL EXEMPTIONS FOR EACH DEPENDENT SUPPORTED BY THE DEBTOR.

IMPACT OF EXEMPTIONS ON GARNISHMENT AMOUNTS

EFFECT ON DEBTORS' FINANCIAL STABILITY
